






FIRST QUARTER FINANCIAL PERFORMANCE BY COUNTRY



YTL Hospitality REIT's Unit Price Movement & Relative Performance to REIT Index (1 October 2017 to 30 September 2025)












MASTER LEASES EXPIRY PROFILE

AUSTRALIA HOTEL PERFORMANCE BY QUARTER (2 OF 2)




